Fee Payable (\$500 for the season):

- Conditions of Use, unless otherwise agreed in writing
- User must be a fully paid up VA12'SC club member.
- Boats are generally only available for one season. This is to allow an equitable sharing of boats amongst Club members.
- The boat can only be used at VA12'SC sanctioned events (i.e. it can not be taken away from the club for personal use or to participate at other clubs or association events, unless agreed in advance by VA12'SC).
- The boat is only available for use on days that VA12'SC has scheduled activities (unless agreed in advance by VA12'SC).
- VA12'SC can not guarantee availability of an alternative boat if the rented boat has been damaged or otherwise becomes unfit for use.
- Breach of any condition entitles VA12'SC to terminate this agreement without notice

User is responsible for:

- rigging / de-rigging; washing of boat, rig and sails; ensuring all equipment kept together and correctly stored in the club rack after use.
- identifying to a Club representative any breakages or problems.
- payment for any damage to boat (other than wear & tear) up to the \$250 insurance excess.
- Ensuring all users of the boat always wear an approved Personal Floatation Device (PFD) when on the water.

VA12'SC is responsible for:

- maintenance and any repairs to the boat as a result of normal usage
- providing storage
- insurance of the boat for club sanctioned activities (NB the hirer must seek permission of the committee for any use beyond club races or club organised practice)

INDEMNITY: To be completed by adult applicant.

I acknowledge that the Vacluse Amateur Sailing Club (VA12'SC), its officers, management committee, race officials, voluntary workers, and members shall not be held liable for any death, personal injury, loss or damage to property howsoever arising and therefore by signing the Dinghy Usage Agreement, I hereby release, to the full extent permitted by state, law and equity, VA12'SC, its officers, management committee, race officials, voluntary workers, and members from all actual and contingent liability in respect of any personal injury, death, loss or damage to any parties or property.

I declare all persons using the VA12'SC dinghy are able to swim at least 50 metres unassisted and are capable of taking care of themselves whilst ashore or on water under normal circumstances. I understand that they must wear approved buoyancy jacket and I accept full responsibility for their safety whilst sailing. I understand that sailing is a dangerous sport or activity and that you can get injured if you are not careful. I also understand that there are dangerous sea creatures in and around the area and in the water.
